**Matters arising from the Minutes:**

The Clerk to follow up on the outstanding matters reported to Ceredigion County Council:

221 Y gwaith o baentio llinellau gwyn ar y ffyrdd yn Llanafan wedi dechrau ond angen cwblhau.

The painting of White lines on the roads has been started at Llanafan but requires completion.

222 Sefyllfa Dwr yn croni ar ffordd ger y Gors yn parhau, cadw ar agenda.

Flooding on the road near New Cross is continuing, keep on the agenda.

223 Gwteri angen glanhau yn y lleoliadau canlynol: ar ben y Rhiw Cnwch Coch; ar y ffordd o Gnwch Coch i Gapel Cynon; Penffordd, y Gors i Lanfihangel-y-Creuddyn gwter wedi gorlenwi gyda drysni a'r dwr yn gorlifo ar y ffordd.

Overflowing gutters on the following roads: top of the hill out of the village of Cnwch Coch and along the road towards Capel Cynon; from Penffordd, New Cross towards Lanfihangel-y-Creuddyn the

- overgrown grass has caused water to seep on the road.
- Continuing to request for the road sweeper to attend to the road up to Capel Carmel, Cnwh Coch a hefyd y ffordd o'r hen Ysgol Llanafan tuag at y B4340. Danfonwyd lythyr at Llywodraeth Cymru yn cyfeirio at y problem a geir o geisio cael hyn wedi gweithredu gan Gyngor Sir Ceredigion.
- Angen arwynebedd newydd ar y ffordd heibio Ysgol Llanfihangel-y-Creuddyn; y ffordd o'r hen Ysgol Llanafan a heibio Maes Chwarae Maes y Felin;
- Shetin rhwng Brynafan a Llanafan parhau angen torri nol. Cyfeiriwyd hefyd at shetin mewn lleoliad arall sydd wedi gor-dyfu ac yn achosi problemau gweledol i deithwyr sydd mewn perygl o achosi damweiniau cas.
- Glanhau y grid-anifeiliaid cyntaf ar y ffordd o Lanfihangel-y-Creuddyn i Drisant wedi cwblhau ond bod angen arwynebedd newydd ar y ffordd.
- Sefyllfa'r ffordd yn rhoi ger Royal Oak, Llanafan yn parhau
- Llifogydd ar y ffordd ger Dolgelynen yn nhwydd garw yn parhau
- Problem tyfiant yn Nantyrhaidd yn parhau,
- Llifogydd mewn sawl lleoliad ar y B4340 rhwng Abermagwr a'r troad am Lanfihangel-y-Creuddyn – Cyngor Sir Ceredigion wedi gwneud gwaith mewn rhai lleoliadau - angen cadw llygad.
- Casgliadau ail-gylchu, bwyd a gwastraff ty yn aml yn cael eu gadael heb gasglu yn Nhrawsgoed/Celt – ni dderbyniwyd cwynion pellach hyd yn hyn.
- Olwynion cerbydau parhau heb eu casglu tuag at yr A4120 – wedi casglu.
- Resurfacing the road passing the School at Llanfihangel-y-Creuddyn; road leading from the old School Llanafan towards Maes y Felin Playing Fields.
- Hedge between Brynafan and Llanafan that needs cutting back still requires attention. Reference was made to another hedge at a nearby location which is so overgrown several near accidents have occurred.
- The first cattle grid has been cleared on the road from Llanfihangel-y-Creuddyn towards Trisant but the road is in dire need of a new road surface.
- Road subsiding near Royal Oak, Llanafan continues needing attention.
- Flooding on the road near Dolgelynen during severe weather continues.
- Overgrowth at Nantyrhaidd Stream continues to be a problem.
- Flooding at several locations on the B4340 between Abermagwr and the junction for Llanfihangel-y-Creuddyn – Ceredigion County Council has undertaken work at some locations – need to keep an eye on situation.
- Re-cycling, food and household waste are regularly left uncollected at Trawsgoed/Celt – no further complaints to date.
- Vehicle wheels have been collected after being fly tipped near to the A4120.

Cyfeiriwyd at gartref o fewn ardal y Cyngor Bro fu heb gyflenwad ffôn/we am bron i pythefnos oherwydd problemau gyda'r llinell Llais Digidol.

- 238 **Rhoddion:** Yn dilyn hysbysu'n y gymuned ac ar y we am geisiadau am nawdd ariannol o'r Cyngor Bro ac amodau Adran 137(4)(a) o Ddeddf Llywodraeth Leol 1972 Gwariant Adran 137 y Terfyn ar Gyfer 2021-22 trafodwyd a chytunwyd ar y cyfraniadau canlynol:
- A response was received from the Member of Parliament stating that he had been in contact with BT fighting against the decision to transfer phones to Digital Voice telephone service due to the limited mobile phone signal within rural communities if there were to be an electricity power cut. Consequently, BT has now decided not to continue with the arrangements to change the service for the time being.
- The response was discussed and although the response was appreciated the situation is still a worry for those residents of Brynafan and Llanafan that have already had to change. It was agreed to re-contact the Member of Parliament to see if support can be given to those residents who have already had to change. Reference was made to a residence within the Community Council area that had lost the telephone service for almost two weeks due to problems with the Digital Voice line.

Ymateb i'w ddanfon yn nodi er fod y Cyngor Bro ar y pryd wedi cyfrannu drwy roi rhodd ariannol at y diffibrilwr ni wnaed y cais am ei leoli yn enw'r Cyngor Bro. Cytunwyd i gynnwys yn yr ymateb hefyd yr awgrym fod swyddogion yr Eglwys yn cysylltu gyda Chymdeithas Llanfihangel-y-Creuddyn i ofyn iddynt gymryd cyfrifoldeb o'r diffibrilwr yn unol gyda trefniadau a wnaed mewn pentref cyfagos ble mae'r trigolion lleol wedi cymryd cyfrifoldeb o'r offer.

It was suggested to include in the response that Church Officers contact the Cymdeithas Llanfihangel-y-Creuddyn to ask them to take responsibility for the defibrillator in accordance with arrangements made in a neighbouring village where local residents have taken responsibility for the equipment.
