6. Correspondence

- (i) A letter was received from a member of the public raising concerns regarding the condition of the Lon Las road from Abermagwr towards Cnwch Coch due to heavy, wide vehicles traveling along the road. The letter is acknowledged and comments passed on to Ceredigion County Council.

7. Any Other Business

- (i) At the junction of the A4120 towards Pisgah there are two areas of land used as passing places but the surface is uneven and muddy. The Clerk to contact the County Council enquiring whether these locations can receive a new surface.
- (ii) Public Bus Routes: a member of the public raised the issue of the inadequacy of bus service in the area. Concern minuted.
