Concerns received from members of the public regarding the following which will be transferred to Ceredigion County Council. |

Trefnwyr yr Wyl yn bwriadu chwarae cerddoriaeth uchel tan 3.00 o'r gloch y bore fydd yn amharu ar drigolion lleol; clawdd ymyl y ffordd cae yr Wyl wedi gordyfu'n sylweddol sy'n achosi risg diogelwch i gerbydau a cherddwyr; consyrn fod yna ddau ddigwyddiad fawr drws nesaf i'w gilydd ar yr un pryd a fydd yn achosi problemau trafniadaeth yn yr ardal;

Festival organisers intend for loud music to be played until 3.00pm in the morning which will impact local residents; The roadside hedge of the Festival field is significantly overgrown which poses a safety risk to vehicles and pedestrians; concern that there are two major events next door to each other at the same time that will cause transport problems in the area;

Review of Community Arrangements of The County Of Ceredigion.
Objections were sent to the Consultation Document from the Boundary and Local Democracy Commission for Wales which recommended the merger of Llanilar Community Council Council and Trawsgoed Community Council.

Ymateb a dderbyniwyd gan Gyngor Sir Ceredigion yn nodi nad yw'r coed dan sylw yn destun Gorchymyn Cadw Coed ac nad ydynt o fewn Ardal Gadwraeth felly nid oes gofyniad cyfreithiol ar y tiffeddiannwr i hysbysu Cyngor Sir Ceredigion am unrhyw waith ar y safle. Os teimlid bod adar yn nythu o fewn y coed gallai'r weithredo o gwmpo'r coed ddod o dan Deddf Bywyd Gwyllt a Chefn Gwlad 1981 ac felly'r Heddlu fyddai'r awdurdod adrodd yn ogystal â CNC pe bai nifer sylweddol o goed wedi'u cwmpo.

Historic trees had been felled on the side of a public road within the Ward. Response received from Ceredigion County Council noting that the trees in question are not subject to a Tree Preservation Order and are not within a Conservation Area therefore there is no legal requirement for the landowner to notify Ceredigion County Council of any work on site. If it was felt that there were nesting birds within the trees the felling could come under the remit of the Wildlife and Countryside act 1981 and therefore the Police would be the reporting authority as well as NRW if there was a significant amount of trees felled.
