- In the centre of the village of Cnwch Coch a water pipe under the road has moved which causes rainwater to run on the road raising a manhole cover which in turn rainwater flows towards nearby houses.
- Blocked/covered drain near Bryngibdda causing rainwater to flow on road.
- Road at Royal Oak, Llanafan. The Local Member is in contact with Ceredigion County Council officers and it is noted that repair work will be carried out at the location but no firm timescale as of yet.
