To consider the application of Dolau Ceunant for a CL Caravan Site with the Caravan and Motorhome Club.

Gwybodaeth cefndirol

Galwyd y cyfarfod gan y Cadeirydd yn dilyn ymholiadau gan drigolion lleol yn dilyn hysbysiad a ymddangosodd y tu allan i eiddo Dolau Ceunant am gais i leoli Maes Carafanau CL gyda'r Clwb Carafanau a ChartrefiModur am hyd at 5 carafán, am ddim mwy na 28 diwrnod ar y tro.

Background information

The meeting was called by the Chair following enquires from local residents following a notice appearing outside the property of Dolau Ceunant for an application of siting a CL Caravan Site with the Caravan and Motorhome Club for up to 5 caravans, for not more than 28 days at a time.

Nid oes angen cais cynllunio ar gyfer safle o'r fath ond roedd cyfle i unrhyw un â diddordeb roi adborth ar y cynnig o fewn 21 diwrnod i ddyddiad yr hysbysiad a hynny'n dod i ben ar y 3ydd o Fedi 2022.

No planning application is required for such a site but there was an opportunity for interested parties to give feedback submissions on the proposal within 21 days of the notice date which would come to an end on the 3rd September 2022.

Ar ddechrau'r cyfarfod darllenodd y Cadeirydd lythyr a dderbyniodd yn nodi rhai pryderon am y cais.

At beginning of meeting the Chair read a letter he had received noting concerns on the application.

Yn dilyn trafodaeth, penderfynwyd ar yr adborth canlynol i'w cyflwyno drwy'r ffurflen adborth ar-lein:

Following discussion it was resolved on the following feedback via the online feedback form:

Ystyriodd Cyngor Cymuned Trawsgoed yr hysbysiad ar gyfer Maes Carafanau a Chartrefi Modur CL yn Nolau Ceunant, Llanfihangel-y-Creuddyn ac roeddent yn gefnogol mewn egwyddor i'r cais, a fyddai'n cyflwyno twristiaeth ac o bosibl yn dod ag economi ychwanegol i'r ardal, ond roedd rhai pryderon sydd angen eu lleisio ynghylch hynny o ran Diogelwch y Ffyrdd.

Mae pum ffordd yn arwain i Bentref Llanfihangel-y-Creuddyn ac nid yw isadeiledd y ffyrdd hynny yn addas mewn rhai mannau ar gyfer cerbydau mawr a'r rhai sy'n tynnu tu ôl iddynt gan fod y ffyrdd yn gul, yn droellog, ac yn cynnwys rhywiau serth mewn ambell fan gydag ychydig iawn o lefydd pasio. Yn aml mae angen atgyweirio wyneb y ffyrdd hyn, tocio gwrychoedd, ac ati.

Mae'r lleoliad, sy'n agos at yr ysgol gynradd leol, yn peri pryder am ddiogelwch a lles disgyblion yr ysgol gyda'r ardal gul y tu allan i'r ysgol yn llawn tagfeydd cerbydau ar adegau dechrau a diwedd y diwrnod ysgol. Pe bai'r safle'n cael ei gymeradwyo, awgrymir y dylid cynnwys gwybodaeth ar bamffledi perthnasol y dylid osgoi cyrraedd a gadael o gwmpas amseroedd dechrau a diwedd y diwrnod ysgol yn ystod adeg y tymor ysgol.

Trawsgoed Community Council considered the notice for a CL Caravan and Motorhome Site at Dolau Ceunant, Llanfihangel-y-Creuddyn and were supportive in principle to the application, which seeks to introduce tourism and potentially bringing additional economy to the area, but there were some concerns that need to be voiced regarding road safety in respect of such an application.

There are five roads leading to the Village of Llanfihangel-y-Creuddyn and the infrastructure of those roads are not suitable in some parts for large and towing vehicles, being narrow, winding, and containing some very steep hills in some places, with very few passing places. These roads are often being in need of surface repairs, hedge trimming, etc.

The location, in close proximity to the local primary school, gives concerns over the safety and wellbeing of the school pupils with the narrow area outside the school being congested at the best of times with vehicles at the beginning and end of the school day. It is suggested that should the site be approved information be included on relevant brochures that arriving and departing should be avoided around school drop off and pick up times during term time.
