Ymateb Cyngor Bro Trawsgoed 2020

Fel Cyngor Cymuned rydym yn cefnogi egwyddor y cais hwn, sy'n ceisio cyflwyno twristiaeth a busnes i'r ardal, ond teimlir bod y lleoliad a gyflwynir ar hyn o bryd ar gyfer y cynnig, sydd yn agos at yr Ysgol Gynradd leol yn anaddas ac amhriodol.

Mae pryderon ynghylch diogelwch a lles disgyblion ysgol yn flaenoriaeth, ac rydym yn deall bod pryderon tebyg wedi'u codi gan eraill yn y gymuned.

Nid oes unrhyw wybodaeth benodol o fewn y cais i nodi sut y bydd y gwastraff o'r cawodydd a'r toiledau compostio'n cael eu gwaredu, a fyddai hyn yn cael effaith amgylcheddol ar y pentref gydag arogleuon annymunol posibl yn deillio o'r safle?

Mae'r cais yn nodi na fydd unrhyw gyflenwad dwr na thrydan ar y safle ond nid yw'r cais yn nodi o ble y daw'r dŵr ar gyfer

the Planning Department/ Committee to consider:

Given that the public roads in the area already require significant repair and maintenance having tourism to the area throughout the year will increase the problems;

It is felt that the entrance to the site is not suitable for permanent development with increased traffic posing a greater risk to a narrow country road.

The materials set out in the plans are not suitable for an image of the village of Llanfihangel-y-Creuddyn, the use of plastic windows and artificial grass etc are not in-keeping with the views of the area.

There's not enough details in the application regarding the drainage system and the water overflow.

The location of the development is too close to a Primary School which will cause concerns of the safety of pupils all year round and not just seasonally.

Response of Trawsgoed Community Council 2020

As a Community Council we support the principle of this application, which seeks to introduce tourism and business to the area, but feel that the location currently put forward for the proposal, which is within the close proximity to the Local Primary School and its grounds is not suitable and inappropriate.

Concerns over the safety and wellbeing of school pupils are paramount, and we understand that similar concerns have been raised by others in the community.

There is no specific information in the application of how the waste from the showers and the composted toilets will be disposed of, would this have an environmental impact on the village with possible unpleasant odours emanating from the site?

Nos Lun 20fed Mai 2024 am 7.30y.h. yn Neuadd Lisburne, Llanafan.

The application notes that there will be no amenities on site but the application doesn't state from where the water for the showers will be sourced from, nor details if and how the site will be lit at night as there will be no electricity in the field?

The applicant states that this is a seasonal proposal but that if requested the tents could be erected during the Autumn and Winter months, would this statement be an invitation to allow the glamping tents to be on site the majority of the year?

We would suggest that the applicant reconsiders an alternative location for the glamping tents, and which are distanced from the Local Primary School.

As it stands in its current location and for the reason stated above, the Community Council objects to the proposal.

Response of the Community Council: No objection.

Sharing of Information

The Community Council received information that historic trees had been felled on the side of a public road within the Ward. Contact to be made with Ceredigion County Council to discuss if relevant permission was received.

New potholes have appeared, in the middle of Cnwch Coch;
near Ty Mawr on the road from Llanfihangel-y-Creuddyn to Trisant;
